## Training Classes and Instructor Bio/CV Scott Dau

- Fire Investigation and Electricity 8 Hours
  - "Which came first? The electrical event or the fire?" The path to potentially answering this question requires a basic understanding of electricity as a roadmap. This presentation will cover what "electricity" is and define basic terms and key concepts to electrically generated heat. The basic components of a residential electrical system will be presented, and their role in contributing to ignition, or being a guide to causes elsewhere in the scene.
- Arc Mapping and Open Neutral 8 Hours
  - The importance of the arc survey, and arc mapping or the lack of arc discovery can be a great source of information to determine your area of origin. We will go over the basics of the concepts of arc mapping, differentiation of arc damage vs. thermal melting, and take a look at the creation of both types of damage by actually causing them on energized and de-energized conductors. This demonstration is always an eye-opener and is never the same twice! Relevant case studies will be presented to show how arc mapping can help solidify your ignition scenario hypothesis.
  - Open Neutral In this presentation, we will explain the concept of an "open" or "floating" neutral – what it is, where it can be found, and how it can present.
     We will take a hands-on look and create a "live" open neutral, which will allow students to actually see the voltages vary as loads change on the circuits.
- Lithium-Ion Batteries 2 Hours
  - They are in the news every day fires attributed to Lithium-ion batteries. This presentation will immerse students in the basic operational concepts and terminology of lithium-ion batteries, and their failure methods. What to look for on your fire scenes that may indicate their presence and what to do with that information. Disassembly of an actual lithium-ion battery will allow students a first-hand look at the components involved.
- High Resistance Connections 2 Hours
  - Resistance is futile. And bad, if it creates heat somewhere that wasn't designed for that heat. This presentation will review and incorporate the basic concepts of resistive heat, and what it looks like AFTER it's the potential cause of a fire, with a relevant case study.

#### Instructor's Bio

Scott is a 34-year career Firefighter/EMT with the Seattle Fire Department. He has been active in fire investigation since 2007, and is a Vice President for the Washington State chapter of the IAAI. On the private investigation side, he conducts investigations for two firms representing several major insurance carriers.

He helped to develop and instruct the "Electrical Aspects of Fire Investigation" class at the National Fire Academy and for new ATF CFI candidates, the NFA's "Fire Investigation for First Responders" course, and has presented at state/local conferences around the nation.

Additionally, he has 30 years of hands-on electrical experience in residential and commercial applications.
